2.0 REPORTS

2.1 Superintendent's Report

Mr. Kaufman spoke about the 180 days vs 900/990 hours-legislation that was passed with the budget this year that allows school districts to meet either the 180-day requirement OR a 900/990-hour requirement. He stated that the school calendar for 24/25 meets both of those requirements for NTSD.

He also discussed HB 1908-this House Bill will require all school districts to hire an armed security guard if it passes. He informed everyone that we are identifying potential grant funding to support expenses with this type of position.

Lastly, Mr. Kaufman discussed the Governor's proposed budget, as it invests heavily in K-12 education. The Governor proposed \$1.1 billion in response to the Commonwealth Court's funding decision.

2.2 Business Manager's Report

All votes were affirmative. The motion carried.

2.3 Buildings and Grounds Report

Daren Bryant provided an update on various projects that have been completed or are in progress throughout the district by the buildings and grounds team, which included eighteen completed work orders. He mentioned that the Guardian boiler water inspections have been completed.

2.4 Grant Update

Becky Koehler announced that the state released several grants within this year's budget and those are intended to address a variety of grant projects, from mental health to school safety to professional development.

Sara LaPoint, 6.5 hours per day Special Education Teacher's Aide, currently assigned to Williamson High School, \$15.62 per hour, effective February 12, 2024. Jessica Glenn, 5 hour per day MTSS Tutor, currently assigned to R.B. Walter Elementary School, \$25.00 per hour, effective February 26, 2024. 3.6 Approval of Increase of Hours (Exhibit #16)

A motion was made by Glen Hallead, seconded by Aaron Smith, to approve the increase of hours of Vicky Wiles, Clark Wood Elementary School, Special Education Teacher's Aide, from 5.5 hours to 6.5 hours per day, for the remainder of the 2023/2024 school year, effective February 13, 2024. All votes were affirmative. The motion carried.

3.7 Approval of Volunteers

A motion was made by Craig Stage, seconded by Kim Strauser, to approve Edward Presor Jr as a volunteer for Westfield Area Elementary School. All votes were affirmative. The motion carried.

3.8 Approval of Website Redesign

A motion was made by Craig Stage, seconded by Glen Hallead, to approve the redesign of the district website by BLaST IU 17, for a cost of \$7,000.00. Roll Call Vote. All votes were affirmative. The motion carried.

3.9 Approval of Parent Square App

A motion was made by Craig Stage, seconded by Aaron Smith, to approve purchasing the Parent Square App for an annual cost of \$10,866.00 for each of the next three years and a onetime fee of \$1,500.00. Roll Call Vote. All votes were affirmative. The motion carried.

3.10 Approval to Fund Projects

A motion was made by Aaron Smith, seconded by Craig Stage, to approve to fund the following projects: Install reheat VAV in TRU over Clark Wood Main Offices - \$120,000.00 (\$50,000.00 previously included in the 2023/24 budget); Replace gang bathroom sinks and mirror at Westfield Area Elementary School \$58,000.00; Upgrade district clock system - \$19,284.00; Replace carpet in music room at Westfield Area Elementary School - \$10,845.00; Repair playground fence and install gates at Clark Wood Elementary School - \$5,000.00. These projects will be completed during the 2023/24 school year and funded by the General Fund. Total additional cost to the 2023/24 budget will be \$163,129.00 due to \$50,000.00 previously budgeted for the Clark Wood Offices. Roll Call Vote. All votes were affirmative. The motion carried.

3.11 Approval of E-Rate Bidding

A motion was made by Glen Hallead, seconded by Greg Cummings, to approve the use of the E-Rate bidding process to upgrade our core network switches. The estimated cost before the E-Rate discount will be \$70,000. Our typical rate discount is around 80%. Roll E-Call Vote. All votes were affirmative. The motion carried.

3.12 Approval of Student Activity Account (Exhibit #16)

A motion was made by Craig Stage, seconded by Julie Preston, to approve the request to establish an CV Sportsmen Club Student Activity Account, as outlined in Exhibit #16. Roll Call Vote. All votes were affirmative. The motion carried.

3.13 Approval of 2024/2025 School Calendar (Exhibit #17)

A motion was made by Glen Hallead, seconded by Aaron Smith, to approve the 2024/2025 school calendar with Labor Day, December 30, December 31, Good Friday, and Easter Monday as official local school district holidays per BEC 24PS15-1502 as outlined in Exhibit #17. All votes were affirmative. The motion carried.

3.14 NTSD Health and Safety Plan (Exhibit #18)

A motion was made by Greg Cummings, seconded by Craig Stage, to approve the district's Health and Safety Plan as outlined in Exhibit #18. Roll Call Vote. All votes were affirmative. The motion carried.

3.15 Pupil Transportation Cost Index Adjustment (Exhibit #19)

A motion was made by Kim Strauser, seconded by Glen Hallead, to approve the PDE pupil transportation cost index adjustment and the base fuel rate increase of 3.4% over the previous year for the 2024/2025 school year. This cost adjustment factor is set by PDE and is utilized by the state for the transportation reimbursement formula and by the district for fuel adjustment allowances and athletic contract rate per mile adjustments. Voice Vote. All votes were affirmative. The motion carried.

3.16 Approval of MOU- Northern Pennsylvania Regional College (Exhibit #20)

A motion was made by Greg Cummings, seconded by Aaron Smith, to approve the Memorandum of Understanding between Northern Pennsylvania Reginal College and the district, as outlined in Exhibit #20. Roll Call Vote. All votes were affirmative. The motion carried.

3.17 First Reading of Policies (Exhibit #21 & 22)

A motion was made by Craig Stage, seconded by Kim Strauser, to approve the First Readings of proposed changes to the following policies: #204 - Attendance and #218 - Student Discipline, as outlined in Exhibits #21and #22. Roll Call Vote. All votes were affirmative. The motion carried.

3.18 204/2025 Yearbook Quote CV (Exhibit #23)

A motion was made by Kim Strauser, seconded by Aaron Smith, to approve the 2024-25 yearbook quote for Cowanesque Valley High School, Jostens, in the amount of \$68.00 per book as outlined in Exhibit #23. Roll Call Vote.

A motion was made by Aaron Smith, seconded by Greg Cummings, to accept the NTSD 2024-27 Comprehensive Plan, as outlined in Exhibit #24. This plan was published on the district's website for its 28-day public review prior to this meeting. All votes were affirmative. The motion carried.

3.20 Additional Vacancies During February

A motion was made by Aaron Smith, seconded by Craig Stage to approve the Superintendent to interview and offer positions to top ranking candidates for any teacher or classified vacancies that may occur between the February and March Board meetings. Those recommendations will be made to the Board at the regular March meeting. (This will eliminate the need to convene a special meeting.) All votes were affirmative. The motion carried.
