WHAT IS TITLE I?

Title I is one of the nation's largest Federal Programs through which school districts receive federal funding to provide supplemental instruction for students based upon academic need. The goal is to increase performance and academic achievement in the areas of language arts and/or mathematics. Our Title I program is designed to help students in grades K-6 improve their achievement in reading and math by providing tiered instruction and intervention resources that are tied to raising the student's achievement.

WHAT HAPPENS DURING TITLE I INSTRUCTION?

- Teachers model literacy and mathematical concepts, skills, and strategies for the students.
- Teachers follow the five components of reading: phonemic awareness, phonics, vocabulary, fluency, and comprehension and the fundamentals of math.
- Teachers focus on individual needs of the student.

How Can Parents/Guardians Get Involved in Their Child's Education?
